CIVIL COMPLAINT

COMES NOW Plaintiff Joshua Shiver, through Pro Se, and files this, his complaint against the

Defendants Acadia Healthcare LLC and Southstone Behavioral Health to-wit:

- Plaintiff was receiving services in Halifax County, Virginia from August 2020 until September 2020
- 2. Defendant, Acadia Healthcare LLC owned and operated Southstone Behavioral Health through its physicians, staff, agents, servants, employees and representatives, who may be served with the process of this court by serving its Administrator.

CIVIL COMPLAINT - 1

Defendant Acadia Healthcare LLC, is an organization based in Franklin, Tennessee who may be served with the process of this Court at 6100 Tower Circle, Suite 1000. Franklin, TN 37067

Defendants Acadia Healthcare LLC is liable and responsible for all the actions, omissions and negligence of its agents, servants, representatives and employees. Defendant Southstone Behavioral Health was a children's residential psychiatric facility catering to children and adolescents offering trauma-based care for children who suffer from cognitive, mental, and social disorders.

- 3. That on or about the dates of August 8th, 2020 thru September 4th, 2020, Plaintiff Sought treatment for Suicidal Ideation, Homicidal Ideation, Bipolar Disorder, and Autism Spectrum Disorder. During these dates, Plaintiff was exposed to unnecessary physical restraint, practices, sexual abuse that failed to provide a reasonably safe and therapeutic environment for the Plaintiff. Defendants violated the acceptable standard of care which was the proximate cause of Plaintiff's Injuries.
- 4. That at all times mentioned herein, the physicians, nurses, aides, technicians, counselors, and others assisting were the agents, servants, and employees acting within the scope of their employment of the Defendant. That through their obvious, negligence and unnecessary practices, proximately caused and contributed to Plaintiffs mental health becoming more serious, severe and sustaining damages. As a result of the negligence of the employees/agents of Defendant, Southstone Behavioral Health and Acadia Healthcare LLC.

- 5. Plaintiff would further assert that Defendants failed to provide a safe and therapeutic environment to treat plaintiff's mental health.
- 6. Plaintiff would state unto the Court that the Defendants grossly and negligently failed to properly observe, treat, and/or administer proper mental health care to Plaintiff.
- Plaintiff would further show that the Defendants are liable and responsible on the basis of Medical Malpractice.
- 8. Plaintiff would show unto the Court that as a direct and proximate result of the negligent actions of Defendants, Plaintiff was caused to endure physical abuse, unnecessarily physical restraint, mental anguish, and be in a unsafe environment.
- 9. That as a direct and proximate consequence of the Defendant's actions, inactions and negligence, Plaintiff alleges that the following damages are recoverable of, from and against the Defendant's as follows, to-wit:
 - A. Pain and suffering;
 - B. Mental and Emotional Distress
 - C. All expenses incurred as a result of the Defendant's negligence

WHEREFORE, PREMISES CONSIDERED, Plaintiff, Joshua Caleb Shiver, brings this action against the Defendants, Acadia Healthcare LLC and Southstone Behavioral Health, jointly and severally, and demands judgment of, from and against the Defendants in an amount in excess of \$2,500,000, together with all costs herein.
